- II. Minutes for approval – June
- III. Welcome and Introductions lead by Diana Fortune.
- IV. Overview of NTCA Correctional Sessions at Conference=
 - Diana gave an overview of the corrections plenary at the recent NTCA meeting in Atlanta. The evaluations had positive feedback for Tara and Sarah. The breakout sessions were well attended; kudos to Texas for the number of participants that called in.
 - Webinar Discussed- A discussion on the need and the feasibility of a national webinar was discussed. Stephanie Ott stated that the RTMCC has corrections on their agenda but as there are a number of national corrections committees in existence they would be looking at the scope of work from the other groups in order to evaluate what role the RTMCC will play in corrections. Stephanie will report to her group to see if they can prepare a presentation with the existing material from the CDC and other organizations to do a national webinar that would be archived. She will also explore the possibility of a video conference with Tara and Sarah repeating their presentation from the plenary session.
 - Sarah commented that there seem to be a number of national organizations that have a corrections committee (ACET, DTBE) and it was imperative that we do not duplicate the work that they are already doing. Mark commented that ACET is the advisory group for TB and we should avoid duplication, each group has its own area of focus. Ann Sittig commented that the education group is aware of the existing groups with corrections focus and would be working with them to ensure that the material is not duplicated.
 - Sarah thinks that there should be a national plan for education in corrections. Lauren said that she will see what the CDC is doing and will include Molly and IJ and see will find out what DTBE is doing for corrections. Ann suggested connecting with education.

- V. Education Committee Update- Ann
- Membership has been expanded to include broader membership, connections with CDC, RTMCC, Ramsey Co, etc. to be sought. Education committee is working to best expand and to help coordinate this effort and to meet the needs of our partners, 12 people have signed up for the education subcommittee already.
- VI. Surveillance Committee Update
- Committee should review what is already being done by CDC for correctional genotyping and denominators for analysis. Requesting CDC to prepare slide set specifically for corrections. RVCT data could be upgraded to include history of incarcerations and this could help show the burden of TB in correction. Discussed possibility of states doing a comparison with ICE/BOP/USMS data to see if person ever in federal custody. Sarah said this could be possible but needed to check the ability on collecting that information.
